1 **ORDINANCE 2013-01** AN ORDINANCE TO APPROVE AND REGULATE ALL-TERRAIN VEHICLE (ATV) and UTILITY VEHICLE (UTV) TRAVEL ON ROADS IN THE TOWN OF RICHFORD, WAUSHARA COUNTY, WISCONSIN, AND 3 PRESCRIBING PENALTIES FOR VIOLATION THEREOF 4 5 6 SECTION I - INTENT The Town Richford, Waushara County, Wisconsin adopts the following ordinance for the operation of 8 All-Terrain Vehicles and Utility Terrain Vehicles upon the roadways listed in Section III. 9 Following due consideration of the recreational value to connect trail opportunities and weighted 10 against possible dangers, public health, liability aspects, terrain involved, traffic density and history of 11 12 automobile traffic, this ordinance has been created. 13 14 SECTION II - STATUTORY AUTHORITY This route is created pursuant to town authorized as authorized by s. 23.33 (8) (b) Wis. Stats. 15 16 The applicable provisions of s. 23.33, Wis. Stats, regulating ATV/UTV operation pursuant to routes are 17 18 adopted. 19 **SECTION III - ROUTES** 20 21 Roads to be open for ATV/UTV routes are as follows: 22 23 Cypress Road West from the Dakota Town Line to 11th Road; 11th Road North to County Road II; 24 Cumberland Road West from County Road II across County Road B to Town of Coloma townline; 25 9th Drive North from Cumberland Road to Cumberland Avenue; 26 27 Cumberland Avenue East to County Road B; 11th Road South to County Road JJ; 28 29 11th Avenue South from County Road JJ to Czech Road; 30 Czech Road East to 11th Court; 31 11th Court South to the Marquette County line. 32 **SECTION IV - CONDITIONS** 33 As a condition for the use of this route, the following conditions shall apply to all operators, and 34 35 passengers: 36 37 A. All ATV/UTV operators shall operate at no more than 35 MPH. B. All ATV/UTV operators shall ride single file on extreme right side of roadways. 38 39 All ATV/UTV operators shall only ride on paved surface of roadways. D. All ATV/UTV operators shall slow the vehicle to 10 MPH or less when operating within 150 40 41 feet of a dwelling. 42 Routes must be signed in accordance with NR 64.12, and NR. 64.12(7)(c). Routes will be open for public ATV/UTV usage daily during the following time periods: 5:00 43 44 AM through 12:00 midnight.
